The program emphasizes competencies for advanced counselling and psychotherapy practice. Students are required to earn 60 credits during 10 terms, culminating in the capstone project, which includes three components: (a) Publishable and Critical Literature Review (PCLR); (b) Appropriate Research Question, and (c) Appropriate Methodology. The DCP program facilitates advanced training in counselling and psychotherapy and career advancement while preparing the highly competent counsellor and psychotherapist to contribute community service. To be considered for admission, applicants must (a) possess a master's degree in counselling or a related discipline, (b) be qualified to or already have registration or certification as a counsellor or psychotherapist, and (c) be currently employed (full-time or part-time) in counselling practice or have access to individual clients as a volunteer.
